**RESOLUTION NO. 2019-07**

A RESOLUTION AUTHORIZING THE CITY OF GRINNELL TO NEGOTIATE WITH CARE AMBULANCE SERVICES OF IOWA CITY, IOWA TO PROVIDE EMERGENCY MEDICAL SERVICES.

**WHEREAS**, the City of Grinnell has determined that it is in the city's best interest to negotiate with CARE Ambulance Service as an independent contractor to provide emergency medical services beginning August 2019; and

**WHEREAS**, the terms and conditions of said service shall be agreed upon and accepted by all parties involved; and

**WHEREAS**, the City, acting pursuant to Chapter 364 of the 2018 Code of Iowa (as amended) desires to attain reliable emergency medical services for its citizens; and,

**NOW, THEREFORE, BE IT RESOLVED BY** the City Council of the city of Grinnell that authorization is given to staff for negotiating an Emergency Medical Services Agreement with Care Ambulance of Iowa City, Iowa.

# CARE AMBULANCE SERVICE

CARE Ambulance initial proposal for providing Emergency Medical Services for / with the City of Grinnell Iowa.

## Proposal (1)

1 fully staffed ALS (as defined in Iowa Administrative Code 641 - Chapter 132) 24 hours per day, 7 days per week for 911 response. Back up provided by already stationed CARE Ambulance as available. Third ambulance placed for use by GFD personnel as assigned.

- Year 1 (2019)                    \$132,500 annually / \$11041.67 monthly
- Year 2 (2020)                    \$137,500 annually / \$11458.33 monthly
- Year 3 (2021)                    \$142,500 annually / \$11875.00 monthly
- Year 4 (2022)                    \$147,500 annually / \$12291.67 monthly
- Year 5 (2023)                    \$152,500 annually / \$12708.33 monthly

## Proposal (2)

1 staffed ALS ambulance (with Paramedic Level provider as defined in Iowa Administrative Code 641 – Chapter 132) 24 hours per day, 7 days per week for 911 response. Second crew member assigned by the City of Grinnell / Grinnell Fire Department. Back up provided by already stationed CARE ambulance as available. Third ambulance placed for use by GFD personnel as assigned.

- Year 1 (2019)                    \$66,250 annually / \$5520.83 monthly
- Year 2 (2020)                    \$68,750 annually / \$5729.17 monthly
- Year 3 (2021)                    \$71,250 annually / \$5937.50 monthly
- Year 4 (2022)                    \$73,750 annually / \$6145.83 monthly
- Year 5 (2023)                    \$76,250 annually / \$6354.17 monthly

## Proposal (3)

911 ALS response provided by already stationed CARE ambulance as available at no cost to City of Grinnell. Back up ambulance provided and staffed by GFD personnel as assigned.
