MINUTES

Mayor Agnew called the meeting to order at 7:00 p.m. with all council members present.

White made the motion, second by Hueftle-Worley to approve the agenda. AYES: 6-0. Motion carried.

Hueftle-Worley made the motion, second by White to approve the consent agenda as follows:

PUBLIC WORKS AND GROUNDS COMMITTEE

Hueftle-Worley made the motion, second by Wray to approve Resolution No. 2021-105 - A resolution approving proposed plans and specifications, proposed form of contract, estimate of cost for construction for 2021 Seal Coat Project. AYES: 6-0. Motion carried.

Hueftle-Worley made the motion, second by Wray to approve Resolution No. 2021-107 - A resolution setting a public hearing on proposed plans and specifications, proposed form of contract, estimate of cost for construction and directing publication of notice to bidders for the Southeast Area Sewer Rehabilitation Project for the City of Grinnell, July 6, 2021, at 7:00 p.m. AYES: 6-0. Hueftle-Worley made the motion, second by Wray to approve Resolution No. 2021-109 – A resolution accepting work on the Fuel Systems Improvement Project for a total of \$409,095.07 and paying the retainage of \$20,454.75. AYES: 6-0. Motion carried.

Hueftle-Worley made the motion, second by Gaard to approve Resolution No. 2021-110 – A resolution authorizing payment of contractor's pay request No. 1 in the amount of \$32,792.24 to Manatts, Inc. of Newton, Iowa for the Reed Street Reconstruction Project. AYES: 6-0. Motion carried.

Hueftle-Worley made the motion, second by Wray to approve Resolution No. 2021-111 - A resolution authorizing payment of contractor's pay request No. 1 in the amount of \$72,533.17 to Manatts, Inc. of Newton, Iowa for the Park Street Inlay (1st Ave to Railroad) Project. AYES: 6-0. Motion carried.

Hueftle-Worley made the motion, second by Gaard to approve right-of-way work by Absolute Infrastructure for work in the east ditch of Hwy 146 (Priority Plastics). AYES: 6-0. Motion carried.

No action was taken on the request from Windsor Manor for removal of trees and brush at Arbor Lake. The Council requested that the request be sent to the Parks & Recreation Board for review.

The draft of FY '23 through '27 Capital Improvement Plan was reviewed. No action was taken.

An update was provided on preliminary work to assess conditions of Lake Nyanza and Arbor Lake.

PUBLIC SAFETY COMMITTEE

White made the motion, second by Hueftle-Worley to approve the fireworks display agreement. AYES: 6-0. Motion carried.

White made the motion, second by Davis to approve the Grinnell Chamber of Commerce request for road closures for the 4th of July parade. AYES: 6-0. Motion carried.

White made the motion, second by Hueftle-Worley to approve the request from 10th Avenue/10th Avenue Place residents for their 57th Annual 4th of July Parade to be held on Sunday, July 4, 2021, at 1:00 p.m., with line up starting at 12:30 p.m. AYES: 6-0. Motion carried.

No action was taken on the request from local merchants to close Main Street between 4th and 5th Avenue from 7 am to 4 pm on Saturday, July 17, 2021, for Ridiculous Day. The Council requested signatures from merchants on Main Street approving the closure of the street.

White made the motion, second by Davis to receive final draft of the EMS report and to direct staff to provide Council information on Fire/EMS services for six cities to which are municipalities to the Council and review the options going forward to determine the best EMS service. AYES: 6-0. Motion carried.

PLANNING COMMITTEE

Bly made the motion, second by Gaard to approve Resolution No. 2021-112 - A resolution approving and authorizing execution of the Iowa Economic Development Authority (IEDA) 2021 Rural Housing Assessment Grant Agreement. AYES: 6-0. Motion carried.
