The Mid-Iowa Narcotics Enforcement (MINE) Task Force conducted two search warrants on the morning of 4/15/19. One warrant was executed at #4 Beck Court in Grinnell, IA and another was executed at 173 385th Ave #101 in Grinnell, IA.

The search warrants were executed as the result of a narcotics investigation by MINE Task Force detectives. The MINE Task Force was assisted by the Iowa State Patrol Tactical Team, the Iowa Division of Narcotics Enforcement, the United States Drug Enforcement Administration, the Grinnell Police Department, and the Jasper County Sheriff's Office.

A search of the properties revealed numerous drug related items, including: methamphetamine, prescription pills, marijuana, other substances awaiting testing and identification, and drug paraphernalia. Multiple individuals were arrested and charged with controlled substance violations.

All criminal charges are merely allegations and the subjects should be considered innocent until proven guilty. This investigation is ongoing.
