UPDATE

Date: January 5th, 2023

Reference: **Press Release: PDI20221137- Shooting- 1016 Pearl Street, Grinnell, Iowa**

Grinnell, IA - December 29th, 2022, 1:40 a.m., Grinnell Police responded to 1016 Pearl Street on a report of shots fired. Investigation revealed several adults were engaged in a verbal argument which turned physical and a handgun was produced. Shots were fired from the handgun, striking an adult male, who was taken to a local hospital and is currently in stable condition.

The Iowa Division of Criminal Investigation is assisting Grinnell Police with this investigation. At this time, the identities of additional individuals involved in this incident will be withheld by law enforcement.

On January 1st, 2023, at approximately 12:13 hours, Grinnell Police Officers arrested Cody Alan McCall age 27 upon being medically discharged from Unity Point-Grinnell Hospital from injuries he sustained during the initial altercation. McCall has been charged with Burglary 1st Degree a Class B Felony, Willful Injury-Causing Bodily Injury a Class D Felony and Going Armed with Intent a Class D Felony. McCall was transported to the Poweshiek County Jail to await his initial appearance.

On January 4th, 2023, at approximately 18:53 hours, Grinnell Police Officers arrested Logan Michael Moline age 20 on criminal charges of Willful Injury-Causing Bodily Injury a Class D Felony, Obstructing Prosecution or Defense an Aggravated Misdemeanor, Assault Causing Bodily Injury a Serious Misdemeanor and Theft 4th Degree a Serious Misdemeanor. Moline was transported to the Poweshiek County Jail to await his initial appearance.

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On the morning of Thursday, December 29, 2022, at approximately 1:40 a.m., Grinnell Police Officers were dispatched to 1016 Pearl Street for a report of shots fired inside the residence. The reporting party, an adult male who resides at the address (referred to hereafter as RJ), stated he had shot Cody McCall (DOB: 09/15/1995) twice inside RJ's residence and that McCall had fled the residence on foot.

RJ was interviewed by law enforcement personnel and stated that around 1:30-1:35 a.m., McCall and two associates had come into RJ's home after RJ had heard a knock at the front door and RJ had yelled for them to "come in". RJ stated almost immediately after entering, McCall began assaulting RJ with punches and with a large kitchen knife, over five inches in length, with McCall forcing the knife to RJ's throat. RJ stated during the course of the assault and struggle for control of the knife, McCall was threatening bodily harm on RJ. RJ stated he was able to push McCall away from him long enough to retrieve a pistol from underneath the living room couch and fire two shots at McCall. The altercation continued momentarily after the gunshots but McCall and one of the remaining associates fled the residence soon thereafter (the other associate had already fled the area by this time). RJ was later treated at a local medical facility for non-life threatening injuries sustained during the course of the altercation.

A witness and friend of RJ (referred to hereafter as EP) who was with RJ at the time of the attack inside the residence, was interviewed by law enforcement personnel and stated while inside RJ's residence, two males entered (McCall and one of his associates) and McCall began attempting to stab RJ in the neck area with a kitchen knife. EP stated RJ then produced a handgun and shot the McCall multiple times. EP stated McCall continued trying to stab RJ and eventually got RJ's firearm away from RJ.


On the evening of Thursday, December 29, 2022, an interview of McCall was conducted by agents of the Iowa Division of Criminal Investigation inside McCall's hospital room where McCall was recovering by the gunshot wounds he had sustained earlier that same day. During the course of the interview, McCall indicated he had traveled to RJ's home with a long, silver, kitchen knife for the purpose of self-defense and with an awareness of there being an established tone of hostility between himself and RJ. McCall stated upon entering RJ's residence, he was immediately told by RJ to leave, which McCall refused to do. McCall stated after a brief verbal altercation between himself and RJ, a physical altercation ensued which involved RJ attempting to gain access to a pistol, McCall punching RJ, and McCall holding a knife to RJ's neck area as a way of trying to stop RJ from using the aforementioned pistol.



AFFIDAVIT

STATE OF IOWA, POWESHIEK COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

At 01:40 AM on 12/29/2022, Grinnell Police officers were dispatched to 1016 Pearl Street for a report of shots fired at that residence. Dispatch stated that the reporting party (referred to hereafter as RJ) states he shot Cody McCall (DOB 09/05/1995) twice in the chest and that "they left on foot."

A Grinnell Police Officer found Logan Moline (DOB 12/27/2002) running southbound from that area. The officer only caught up to Moline because he slipped and fell on a patch of ice in the parking lot of an apartment complex, located in the 500 block of 4th Avenue. A kitchen type knife over five inches in length was found near his person, and on his person was a Taurus handgun. Grinnell Police Officers and Poweshiek County Deputies went to the scene at 1016 Pearl Street where they found the reporter, RJ, and a friend of his (referred to hereafter as EP).

EP was interviewed at the Grinnell Police Department. EP made a statement that he was hanging out with RJ tonight at 1016 Peal Street, RJ's Apartment. RJ took a phone call from an unidentified female and told EP she was going to come over. When she arrived, RJ opened the door for her when two males (who EP doesn't know) rushed in. One male told him to sit down otherwise he'd kill EP. The other male started trying to stab RJ in the neck with a kitchen knife. EP states that RJ produced a handgun and shot the male with the knife two times. After that, the male kept trying to stab RJ. He got RJ's firearm away from him, but then the two males left the house. After that, both RJ and EP called 911.

RJ told Grinnell Police officers that Cody McCall and Logan Moline had entered his residence and then both of them had assaulted him. He states that McCall had a kitchen knife, over five inches in length, and put it up to his throat. McCall also told EP to put his hands above his head, crossing his fingers. RJ pushed McCall away from him and went to his couch to retrieve a pistol from underneath it. He successfully retrieved the pistol and fired two rounds into McCall's chest. After that, both McCall and Moline started to hit him, but when McCall realized he was shot he told Moline to "kill the motherfucker." RJ called 911 while the fight was still happening. He states that the scuffle should be audible on the 911 call. Moline then yelled "we gotta get out of here." RJ stated that he released the magazine from his gun, a Taurus brand handgun, because he was afraid they would take it and use it on him. RJ states that there should be a case for his gun and two magazines near his couch. After RJ released the magazine, McCall and Moline left the house.

RJ has bodily injury on his person, both a cut on his hand from a knife and swelling to his left eye from the assault. He was treated at the hospital. RJ's weapon was a Taurus G2C pistol which has a value of approximately \$300.

Logan Moline was interviewed by a Special Agent with the Iowa Division of Criminal Investigation. He admitted to the agent that the kitchen knife used by Cody McCall during this incident was on or near his person in the moments just prior to being stopped by Sergeant Moore. He also admits that the gun was on his person. He admits to fleeing the scene with the items because he was afraid. A search of Logan Moline's person was conducted pursuant to a search warrant for fingerprints, photographs, any blood on his person, a hair sample, and a buccal swab. During that search there was injury to his hand consistent with punching another person.

He states that McCall had a kitchen knife, over five inches in length, and put it up to his throat. McCall also told EP to put his hands above his head, crossing his fingers. RJ pushed McCall away from him and went to his couch to retrieve a pistol from underneath it. He successfully retrieved the pistol and fired two rounds into McCall's chest. After that, both McCall and Moline started to hit him, but when McCall realized he was shot he told Moline to "kill the motherfucker." RJ called 911 while the fight was still happening. He states that the scuffle should be audible on the 911 call. Moline then yelled "we gotta get out of here."
